Automatic Fee Payment for Annual IRA Account Administration Fee

The financial institution must be a member of the Automated Clearing House (ACH). Deductions will be processed as designated for a one-time fee payment or recurring fee payment annually for the IRA Account Administration Fee. Preferred Trust Company as Custodian reserves the right to cancel an automatic fee payment should the ACH deduction be rejected due to insufficient funds or incorrect account information.
